### FACILITIES USAGE AGREEMENT FORM

UPON ARRIVAL AND DEPARTURE CHECK IN WITH FACILITY COORDINATOR.  
AFTER UNLOADING, ALL VEHICLES ARE TO BE PARKED IN DESIGNATED

ADULT IN CHARGE OF THE GROUP

TO USE THE POOL; EACH GROUP MUST PROVIDE THEIR OWN CERTIFIED LIFE  
GUARD TO REMAJN ON DUTY WHILE CAMPERS ARE IN POOL AREA.

ALL BOATERS MUST WEAR LIFE PRESERVERS AT ALL TIMES WHILE IN BOAT.

ALL FACILITIES MUST BE LEFT IN THE SAME CONDITION AS FOUND UPON  
ARRIVAL. ANY DAMAGE DONE TO GROUNDS AND FACILITIES WILL BE  
REPAIRED  
AND DEDUCTED FROM DEPOSIT AND/OR BILLED DIRECTLY TO RENTER,  
PAYABLE UPON RECEIPT.
